Dear wedding couple:

This is the contract for the three-hour LOADED wedding package. All photography is to be performed by Alicia Earle Renner unless there is an emergency. This agreement includes three (3) hours of shooting time and all editing time for a total of \$1,500.00. Shooting the night before or for extra hours will be at \$350.00 per hour shooting time.

You will receive CD's of the full-size images from the wedding from which you will be able to print large photos from your personal computer or through a printing service. All images will also be uploaded to our print service for the couple, the families, and guests to order prints. You have the ability to order prints from this service in color, black & white, and in many different sizes. A major benefit of this service is that it allows family and friends to obtain prints without your assistance.

Your prints will be available at: <http://keywestweddingphotographer.com/purchaseprints.html> then click on the link to visit the gallery of your event. Alicia Earle Renner has the right to use any image for advertising in print or on the web.

The image count will be around 250 to 350 images taken during that time. The photographer will edit out images that reflect people with closed eyes, etc. so the final count of images may depend on the circumstances. Average for this time is 300 edited images. Alicia Earle Renner will be performing extensive editing including the use of filters and other artsy applications.

You will receive:

- 2 artsy black and white enlargements (photographer's choice\*) 16x20 inches.
- 50 4x6 inch prints (couples choice) picked from the upload to professional printing service.
- 1 CD with black and white conversion of the whole wedding

\*The photographer's experience after hundreds of weddings has been that the bride and the photographer end up picking the same favorites year after year so, to save time, the photographer will print her favorites and add her special touches to them. Please trust the eye of the professional.

The bride agrees to a five hundred dollar deposit to be sent to the photographer. This deposit is nonrefundable as it secures for you the date of your event. The total price of this package is \$1,500.00. The remaining \$1000.00 is to be paid on the night of the wedding or before the wedding date by mail. The photographer agrees to have all images posted on the website within two months and to have the CDs and the prints mailed within the same interval. Contacting the photographer to find out "if the images are ready" before this period has elapsed shall fully release the photographer from the obligation to deliver the images in such a timely manner.
