Dear wedding couple:

This is the contract for the "Perfect" wedding package. All photography is to be performed by Alicia Earle Renner unless there is an emergency. This agreement includes all shooting time and all editing time to cover your wedding, two hour rehearsal dinner, reception, and set shots with lighting for a total \$6,000.00 over the course of your wedding day and the evening before.

You will receive CD's of the full-size images from the wedding from which you will be able to print large photos from your personal computer or through a printing service. All images will also be uploaded to our print service for the couple, the families, and guests to order prints. You have the ability to order prints on this service in color or black & white, and in many different sizes. A major benefit of this service is that it allows family and friends to obtain prints without your assistance.

Your prints will be available at: <http://keywestweddingphotographer.com/purchaseprints.html> then click on the link to visit the gallery of your event. Alicia Earle Renner retains copyright and the right to use any image taken during the event for advertising purposes.

The photographer will shoot your entire event and may enlist an assistant to increase the photo opportunities and enhance lighting for some shots. The photographer will eliminate poor images (e.g., eyes closed eyes) so the final number of images will depend on the circumstances, including the willingness of the participants to have their photos taken.

You will receive:

- Extensive artistic editing using filters and treatments for image enhancement.
- 300 4x6 inch prints (your choice)
- 10 artsy black and white enlargements (photographer's choice*) 16x20 inches.
- 1 20" x 24" giclee (canvas) prints on gallery frames (photographer's choice*).
- 1 CD color jpegs 1CD images converted to black and white.
- Three same copies of a linen-bound (1 book) coffee table book telling the story of your wedding in images.

*The photographer's experience after hundreds of weddings has been that the bride and the photographer end up picking the same favorites year after year so, to save time, the photographer will print her favorites and add her artistic touches to them. Please trust the eye of the professional.

The bride agrees to a \$1,000.00 deposit to be sent to the photographer. This deposit is nonrefundable as it secures for you the dates of your event. The total price of this package is \$6,000.00. The remaining \$5,000.00 is to be paid on the night of the wedding or before the wedding date by mail. The photographer agrees to have all images posted on the website within 90 days and to have the CDs, prints, and and books mailed within 120 days. Contacting the photographer to find out "if the prints are ready" before this period has elapsed shall fully release the photographer from the obligation to deliver the images in such a timely manner.
